



Decisions of the Council of the Doctoral School of Applied Informatics and Applied Mathematics

Decision No 202

Decision 202/1: The Council of the Doctoral School of Applied Informatics and Applied Mathematics supports the request of Dr. Levente Kovács to transfer 50% of the topic supervision of PhD student Róbert Pethes (by Dr. Árpád Baricz) should be given to Dr.habil. Johanna Sápi (Mrs. Sájevics).

Dr. Johanna Sápi has recently successfully habilitated, and as she has recently given birth to a child, her publication activities have been temporarily suspended. However, this break is now over. With her previous strong publication record, she is now almost at the point of fulfilling the requirements for her core membership and she is expected to do so this year. With this change of supervisor, the requirement that she has to have an active PhD student is fulfilled.¹

¹REGULATIONS FOR DOCTORAL STUDIES AND HABILITATION AT THE UNIVERSITY OF ÓBUDA

Budapest, 2023 (Version 11, effective from 19 September 2023, consolidated with the amendments)

Head of the Doctoral School, Deputy Head

11. §

(3) The Council of the Doctoral School (hereinafter referred to as DIT) may elect a Deputy Head of the DI from among the DI's core members. The duties and powers of the Deputy Head of the DI shall be laid down in the DI's rules of procedure.

D5) Rules for compliance with the rules of the DI

D5/A. Conditions of compliance with the rules of the trustees

(1) The general personal conditions for compliance with the staff regulations are laid down in Article 8(4) to (8) of these Regulations (Article 2, Article 3 of the Act No 387/2012 Coll.).

(2) A regular member shall carry out more than 70% of his doctoral training activities in the DI of which he is a regular member.

(3) Age requirements for regular members:

(a) The head of the DI shall be 65 years of age in the year of the establishment of the DI, and in the year of the evaluation of a DI in operation - change of head the age of 70 years, even after a change of management;

(b) a university lecturer or researcher who is under 65 years of age in the year of the establishment of the DI or under 70 years of age in the year of the evaluation of the DI in operation.

(4) Have 5 articles published in the ODT database in the last 5 years and an additional 5 articles in the discipline, and update this list regularly each year.



Decision 202/2: The Council of the Doctoral School of Applied Informatics and Applied Mathematics regrets the sudden and tragic death of Dr. Katalin Szenes. Her death has left Bence Tureczki PhD student without a supervisor (50% "administrative" supervisor is József Tar).

The DIT agrees to allow Dr. József Tar to contact Dr. Krisztián Kósi formally to consider his ability to continue Bence Tureczki's PhD activities as a subject leader.

Decision 202/3: Dr. György Eigner, Dean of the John von Neumann Faculty of Informatics, submitted to the Council of the School an additional extension request for István Lovas PhD student to extend the duration of his doctoral studies. After reviewing his previous requests for extensions, the DIT has decided that it is no longer in a position to grant a further extension. It is therefore proposed to István Lovas that, if the material currently available to him is sufficient to initiate the procedure for the award of the degree, he should start the procedure with it. If his existing materials are not sufficient for this, he will have to be dismissed as a PhD student, but we expect that he will apply for an "Individual Training Order" in the next admission cycle with the materials he already has, and that he will be able to successfully complete his PhD in this form.

Decision No.202/4: The Council of the Doctoral School of Applied Informatics and Applied Mathematics in its Decision No.188/4 supported the joint application of Tibor Gergely László PhD student and Dr. Zoltán Tóth, supervisor, in which they requested to postpone the submission of the doctoral dissertation and at the same time the final deadline for the start of the degree procedure to 31.12.2024. In accordance with their commitment, they have now proposed the members of the Evaluation Committee, a proposal supported by the DIT as follows

(5) Have an active thesis or active doctoral thesis.

(6) Regularly check the regularity of the compliance with the core curriculum on a yearly basis by EDHT.

D5/D. Regular disciplinary publication criteria

The disciplinary conditions detailed in section D5/D must be fulfilled from 1 September 2024, until which date the regularity conditions of the University of Óbuda, version 8 EDHSZ, in force from 13 June 2022, shall apply.

(11) Engineering discipline (except Architecture): be the author of at least two Q1 or Q2 articles published in a foreign language in a field relevant to the discipline or at least one monograph published by a recognised international publisher. Q1/Q2 publications may be replaced by a monograph only in the discipline of Military Engineering. A Q1 article can be substituted by a domestic patent, a D1 article by an international patent, and a Q2 article by a trademark/design application. **For publication activity, at least two thirds of the linear parameters of the numerical discipline indicators used in the habit assessment of applications for the award of the doctorate of the Academy of Sciences must be fulfilled...**
